THIS ADVOCACY WORK INCLUDES DIRECT LOBBYING WITH THE STATE LEGISLATURE AND OCCASIONALLY AT THE FEDERAL LEVEL ON LAWS THAT ARE DESIGNED TO PROTECT THE HEALTH OF NEW HAMPSHIRE'S 1,000 LAKES; AND TO ENABLE THE APPROPRIATE STATE AGENCIES TO EFFECTIVELY IMPLEMENT CORRESPONDING LAKE RESTORATION AND PRESERVATION POLICIES AND PROGRAMS.
