Navigating the Waters: Ensuring Resilient Futures for New Hampshire's Lakes Presented by: Ted Diers, Assistant Director of the Water Division, New Hampshire Department of Environmental Services

Our lakes continue to face challenges like new invasive species, increasing cyanobacteria blooms, impactful erosion from more extreme weather events, and overuse from population growth. What's becoming clear is we need to plan on creating resilient lakes that can withstand these challenges. Ted Diers, the Assistant Director of the Water Division at the New Hampshire Department of Environmental Services, will discuss navigating the complex intersection of environmental science, policy, and community engagement and will delve into actionable strategies for building resilience for clean and healthy lakes.

A. Lakes Legislative Update

What happened in the 2024 legislative session that affected our lakes? Attend this session and find out. Andrea will provide an overview of the New Hampshire legislative process and summarize the lake priority bills NH LAKES weighed in on. Learn how your group can join the Lake Advocates Network, a statewide network of lake-minded people like you working with their community to initiate and support public policies and laws that restore and preserve the health of our lakes.

B. Defending our Lakes from Invasive Species

Attend this session for an overview of the status of aquatic invasive species infestations in New Hampshire's waterbodies, including the newly discovered spiny water flea. You'll find what can be done to prevent and identify new infestations. And, you'll hear the story about how one local group defended their pristine lake last summer from becoming infested with an invasive plant thanks to the Lake Host and Weed Watcher programs and some quick local action.

C. LakeSmart Communities: How to Rally a Community Into Action

The Kezar Lake Protective Association was the first group to receive the prestigious LakeSmart Community Award in New Hampshire. Over 50 percent of property owners around Kezar Lake have participated in the LakeSmart Program by taking the LakeSmart self-assessment survey and inviting the NH LAKES LakeSmart Team to conduct a property visit. Hear how this community came together to do all they can to protect their beloved lake and learn how you can rally your community into action.

D. "We've got high water—now what?"

During the summer of 2023, many of New Hampshire's lakes experienced the highest water levels due to record-breaking rain events. This left many lake communities wondering how to protect their properties and the lake. You'll hear from one lake community that advocated the state for an emergency no-wake order and encouraged community members to take a temporary no-wake pledge. You'll also hear from the only lake community in New Hampshire with an emergency no-wake order established in law triggered when waters reach a certain level.

A. New Hampshire's Cyanobacteria Plan: A Statewide Strategy

Presented by: Dave Neils, Chief Aquatic Biologist, New Hampshire Department of Environmental Services

In November 2023, the New Hampshire Department of Environmental Services released a statewide strategy to prevent the increase of, and eventually control, cyanobacteria blooms in New Hampshire's surface waters. The plan was required by the state legislature and included input from a 17-person cyanobacteria advisory committee. The plan establishes key strategies, goals, and actions to curb cyanobacteria bloom occurrences and risks.

B. Lake Level Management: A Balancing Act

Lake-level management can be complex. It requires monitoring water levels, regulating outflows, and implementing emergency response plans. Find out how and why lake levels are managed in New Hampshire. And hear about some challenges the New Hampshire Department of Environmental Services faces when balancing various uses of our lakes, public safety, the changing seasons, and our changing climate.

C. Neighbors Helping Neighbors Reduce Polluted Runoff Water

Lake Kanasatka in Moultonborough, New Hampshire, has experienced severe and prolonged toxic cyanobacteria blooms over the past several summers. But the residents of this beloved lake community haven't given up. Instead, they've doubled down and are doing all they can to restore the health of the lake—including rolling up their sleeves and getting to work! Join this session to hear how this community has successfully engaged individuals with hands-on polluted runoff water reduction projects. You'll leave the session inspired and armed with practical tips to get your community involved in rolling up their sleeves, too!

D. Conserving Land Parcels—Big & Small—for Clean & Healthy Lakes

A. Innovative Local Policy for Resilient Lakes

Lake association leaders will learn to conduct septic surveys independently or work with professionals in this session. Hear about the basics of septic systems, including their operation, maintenance, and potential impacts on lake water quality. You'll learn how to identify areas where septic systems may be causing pollution and how to conduct a survey to determine their condition. You'll also learn how to communicate findings to homeowners and work with them to address identified issues.

A. Run for Office: Help Shape Local and State Lake Policy!

Our lakes need a coalition of concerned and supportive leaders to initiate, support, and protect lake-friendly policies at the local and state levels. Being elected to office in your municipality can be a great way to help ensure your town governs in a lake-friendly way. And, by being elected to the state legislature, you can help ensure lake-friendly laws are passed that will positively impact restoring and preserving lake health statewide. Hear personal experiences from municipal representatives and New Hampshire legislators about running for office and opportunities they've had to stand up for clean and healthy lakes.

B. "We've got cyanobacteria—now what?"

This past year was the fourth year in a row our lakes set a record for cyanobacteria blooms in our lakes. Reducing polluted runoff water, combined with education and outreach efforts, are the best opportunities to reduce the risks and impacts of cyanobacteria blooms.
