4a (Code:) (Expenses \$ 58,884 including grants of \$) (Revenue \$) Advocacy: NH LAKES is an advocate for clean and healthy lakes. This advocacy work includes direct lobbying with the state legislature and occasionally at the federal level on laws that are designed to protect the health of New Hampshire's 1,000 lakes; and to enable the appropriate state agencies to effectively implement corresponding clean and healthy lakes policies and programs. NH LAKES also works at the municipal level helping its local partners to implement lake-friendly ordinances, policies, and programs. In addition to direct lobbying, NH LAKES performs indirect lobbying by engaging its membership community in grassroots lobbying of the state legislature. NH LAKES carries out its work in a collaborative manner with other organizations and groups throughout New Hampshire and periodically conducts research in order to provide the strategic direction and factual basis for its advocacy positions.

4b (Code:) (Expenses \$ 586,956 including grants of \$) (Revenue \$ 582,991) NH LAKES administers a number of conservation programs. The largest of which is the Lake Host Program which is an educational and courtesy boat inspection program administered by NH LAKES in cooperation with local participating groups to prevent the introduction and spread of aquatic invasive species from waterbody to waterbody. NH LAKES secures grants to hire and provide payroll and payroll services for approximately 271 seasonal employees (and 431 volunteers) working as Lake Hosts with local sponsoring groups (lake associations, municipalities) at approximately 101 public boat ramps. Local sponsoring groups are required to match the payroll amount provided by NH LAKES at a minimum of 100% either through in-kind volunteering or by contributing cash to the program which NH LAKES allocates towards local Lake Host payroll. During the summer of 2018, Lake Host staff and volunteers inspected over 86,813 boats and discovered and removed 26 plant fragments of invasive species. (The net gain shown for this program reflects allowable overhead that was not picked up in the tax return.)

4c (Code:) (Expenses \$ 123,620 including grants of \$) (Revenue \$ 62,685) Educational Outreach (Lakes Congress 2018, Watershed Warriors and General Outreach) Lakes Congress: Every year, NH Lakes hosts a day long workshop focusing on topics of lake stewardship. Watershed Warriors: NH LAKES developed this curriculum, with a younger audience in mind. The Watershed Warrior program is designed for children and their families to take action to keep lakes and watersheds healthy. Traveling through a series of different stations of an activity circuit, participants experience hands-on fun while learning about lake ecology and simple everyday things that people can do to keep lakes healthy.
